Part A: Information Overview

i. Introduction

The Energy Industry Competency Framework (EICF) is developed by the Energy Department at the Prime Minister's Office (EDPMO) through a collaboration with Institute Brunei Technical Education (IBTE) and the Oil and Gas Industry. The EICF aim to produce quality and competent local workforce to the Oil and Gas Industry, therefore it provides a direct link between the knowledge, skills and attributes required in the workplace and the content that is used to provide the formal qualifications that underpin occupations and workplace roles.

This year the EICF reach another milestone with the delivery of the EICF Phase 2 Programs and strives to deliver programs that would be beneficial for both Oil and Gas and Non-Oil and Gas sectors. Therefore, three more programs introduced under the Industrial Skills Qualification Programs (ISQ) whereby one of the three programs is being developed with close collaboration with the Land Transport Department (LTD) under the Ministry of Communications (MinCom).

ii. Scope of Work

The brief scope of work shall include but not limited to, providing training programs commencing **September 2015**, based on the Skills Standard as set by the Industry for the following ISQ Programs:

1. Industrial Blaster and Painter

A BLASTER PAINTER is involved in cleaning and preparing surfaces for paintings using blasting equipment; applying of protective paints and coatings on steel structures and equipment and other materials. A blaster painter usually works as part of a team and works closely with other skilled workers such as riggers and potman. A blaster painter most often works from written and verbal instructions and is required to take direction from managers, foreman/supervisors and technicians.

2. Rig Crew

A JUNIOR RIG CREW is involved in various processes/ procedures of drilling and well operation. A junior rig crew usually works as part of a team and works closely with other skilled workers such as roustabouts, drill riggers and rig painters. A junior rig crew most often works from written and verbal instructions and is required to take direction from managers, foreman/supervisors and technicians.

3. Professional Driver

A PROFESSIONAL DRIVER is involved in driving heavy vehicles (Rigid and Articulated) in a safe manner, courteous and responsible manner. Professional Driver will be able to understand the risk associated with day to day driving; identify the main causes of heavy vehicle crashes and damage; fitness to drive; vehicle safety inspection; vehicle technology; understand basic loads behaviour (Vehicle Dynamics); centre of gravity; system of vehicle control; speeding management and breaking techniques; Brunei Road Law; and basic first aid.

iii. Requirement

This EOI is open to **Local** and **International** companies who are registered in providing training programs of locally and/or globally. International companies expressing interest are required to demonstrate the proposed/current local participation either through technical partnership or Joint Venture.
