The Ministry of Energy, Brunei Darussalam wishes to facilitate the development of a 30 Megawatt AC Solar Photovoltaics Power Plant ("SPVPP"). This Invitation to Tender ("ITT") covers the construction and operation of the 30 Megawatt AC SPVPP with a Power Purchase Agreement ("PPA") with the Department of Electrical Services ("DES"), Brunei Darussalam. The Awarded Tenderer is required to form a Joint Venture ("JV") with a local Brunei Government-Linked Company ("GLC") Post-Award. Tenderers that can provide higher In-Country Value have an advantage.

In this context, the Ministry of Energy invites international solar developers to invest, build and operate 30 Megawatt AC Solar Power Plant ("SPVPP") on a remediated landfill which shall entail the following summary of the scope of works:

- Provide relevant engineering design and documentation.
- Procure materials of the plant and related construction and installation processes.
- Provide all civil works associated with construction and ongoing operation of the SPVPP.
- Provide detailed O&M manual for Operations of the Facility.
- Conduct Independent Acceptance Testing and Performance Test.

The ceiling tariff is set at BND 0.0705 or BND 7.05 cents per KWh of Energy for a proposed duration of 25 years in the PPA.

Who are qualified to tender?

This invitation to tender is open to renowned and experienced solar developers that have:

- Proven and demonstrated track record of at least 5-year duration of having designed, built and commissioned utility size solar projects within time and budget, either regionally and internationally of a Total Capacity of at least a total of 50 Megawatt AC Capacity.
- Demonstrated experience in solar plant O&M and associated HSE as evidenced by current projects and PPAs to which they are the contracted party.
- Demonstrated their capability to undertake and deliver the project.

International Tenderers are allowed and strongly encouraged to form a Joint Venture (JV) Partnership with a local Brunei company. Local companies that participate in this Tender must have Active Ownership in the Joint Venture and be comprised of at least 50% Local Ownership and has experience preferably in Energy and/or Engineering in the past 5 years.

Further requirements:

- 1. Net Worth (Assets Liabilities) of Company of at least BND 13.5 million.
- 2. Proof of support or backing from financial institution for the financing of the project.
